Montrose VA Food Pantry Collection...

Our Yorktown Post #1009 continued our support of the Montrose VA Food Pantry with our annual food collection on Saturday, October 13th from 9 AM to 1 PM. Each year we set up tables at the A&P supermarket in Shrub Oak and the A&P supermarket in Yorktown and collect nonperishable food items to help the veterans-in-need who utilize the food pantry to survive.

The day was cold when we started the collection but the warmth and generosity of the people of Yorktown helped counter the weather. 12 Legionnaires donated a few hours of their time to make this our most successful collection to date. In just four short hours we collected 15 full shopping carts of food and \$520 in cash donations for the pantry.

When the collection ended for the afternoon, Duke Searles, the manager of the VA Food Pantry at Montrose, arrived to pick up the donations in a new van donated in the memory of a US Marine who was killed in Afghanistan. The van has graphics clearly identifying that it is with the Food Pantry and has the late Marine's name emblazed on it. Hopefully people who see the van will have it dawn upon them that the VA needs to have a food pantry to help veterans survive today... and that those who donated the most(the van) had already given the most... their friend and veteran named on the van. Our Four Chaplains Ceremony

In February of 1943, four Chaplains in the US Army on a troopship in the North Atlantic experienced the ultimate test of man and faith when their ship was torpedoed and sunk. They handed out life vests and kept the men calm. When the life vests ran out, they gave up their own to save four more men. As their ship slipped into the icy cold sea they were seen praying, locked arm-in-arm with their shipmates.

Our Yorktown Post believes their bravery and faith should be commemorated and each year we hold a 1 hour ceremony to remember them. Last year we had four members of the local clergy represent these Chaplains, we had over 30 students from Mildred Strang Middle School present our nation's colors in Revolutionary War uniforms, and everyone came away a little prouder of the religious diversity our country has come to represent.

Tidbits of Information

It's amazing what you can learn at one of our Post meetings. Often people assume that everyone around them knows all about programs or discounts that they are aware of. Here are a couple of tidbits that some veterans may not know about.

The New York State School Tax Relief Program (STAR) provides homeowners with two types of partial exemptions from school property taxes. If you earn less than \$500,000 and own and live in your home, you're probably eligible for the STAR exemption.

Two types of STAR exemptions: Basic STAR

- available for owner-occupied, primary residences where the resident owners' and their spouses income is less than \$500,000
- exempts the first \$30,000 of the full value of a home from school taxes

Enhanced STAR

- provides an increased benefit for the primary residences of senior citizens (age 65 and older) with qualifying incomes (\$79.050 or less)
- exempts the first \$63,300 of the full value of a home from school taxes as of 2013-14 school tax bills (up from \$62,200 in 2012-13)

STAR exemptions apply only to school district taxes.

There are three different property tax exemptions available to veterans who have served in the U. S. Armed Forces, including veterans who have served in the U.S. Army, Navy, Air Force, Marines and Coast Guard.

Obtaining a veterans' exemption is not automatic - if you're an eligible veteran, you must submit the initial exemption application form to your assessor. The deadline in most communities is March 1 - please confirm the date with your assessor.

You can only receive one of the three exemptions listed below.

- Alternative Veterans' Exemption
 - Available only on residential property of a veteran who has served during a *designated time of war*, or who has received an expeditionary medal
 - Currently available in over 95 percent of the county, city, town, and village taxing jurisdictions across the state. The remainder of these jurisdictions may choose to offer this exemption in the future
 - Veteran applicants should check with the assessor or clerk in the municipalities in which they respectively reside to see whether the alternative veterans'™ exemption is offered
 - Authorized by Real Property Tax Law, Section 458-a
- Cold War Veterans' Exemption
 - Available only on residential property of a veteran who served during the Cold War period
 - Counties, cities, towns, and villages have the option to offer this exemption to qualified veterans
 - Check with your assessor or clerk to see whether the Cold war Veterans' exemption is offered
 - Authorized by Real Property Tax Law, Section 458-b
